Simpsonville Fire Department hiring notice:

Simpsonville Fire Department will be accepting applications to create a hiring list for anticipated opening(s) of a full-time fire fighter/EMT. This will be a 56-hour work week, 24 hours on duty and 48 hours off duty. Applications will also be accepted for individuals seeking part time employment. Applications can be picked up in person at 121 Citizens Blvd. Simpsonville, KY 40067 or you can request an application by emailing [bobby454@simpfire.org](mailto:bobby454@simpfire.org) . Completed applications are to be submitted via in person or by postal mail. The application process will be open on July 20th, 2022 and will close on August 12th, 2022 at 4pm.

**Minimum requirements to apply for full time:**

Applicant must be 18 years of age by the time of hire.

Applicant must meet the Kentucky State Fire Commission requirement of 150 hours and the ability to reach the 400 hour or IFSAC I&II certification within the first year of employment.

Applicant must have current EMT-B certification and be in good standings according to the Kentucky Board of EMS.

Applicant must have a current CPAT card according to the Kentucky State Fire Commission or have been employed as a full-time fire fighter in the State of Kentucky within the last year prior to the hire date.

Applicant must have a valid KY or Indiana driver's license.

Applicant must have NO felony convictions or multiple misdemeanors (more than 2). Any misdemeanors will be reviewed on a case-by-case basis.

**Minimum requirements to apply for part time:**

Applicant must be 18 years of age by the time of hire.

Applicant must meet the Kentucky State Fire Commission requirement of 150 hour certification.

Applicant must have current EMT-B certification and be in good standings according to the Kentucky Board of EMS.

CPAT requirement as stated for full time employment is desirable, but not required.

Applicant must have a valid KY or Indiana driver's license.
