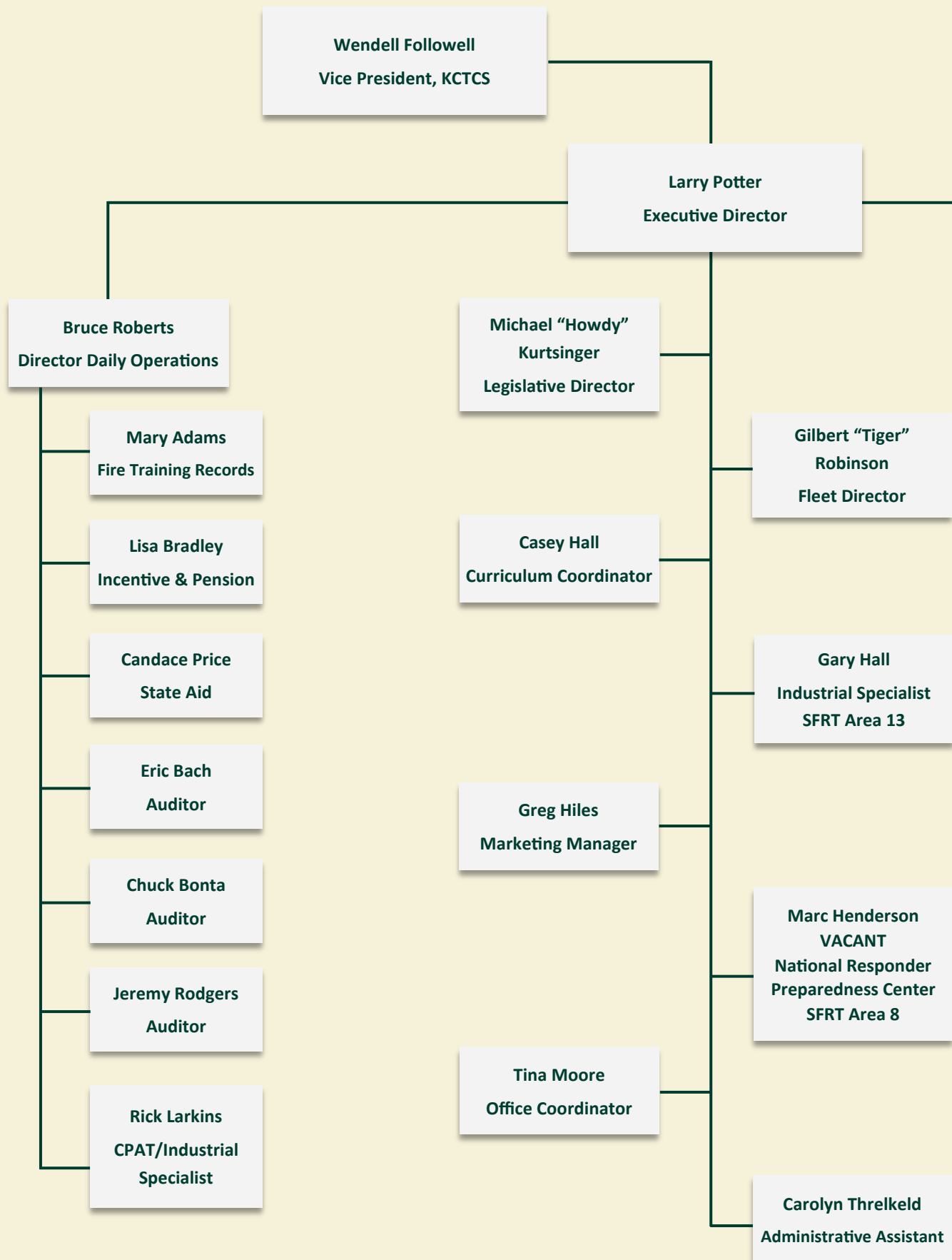

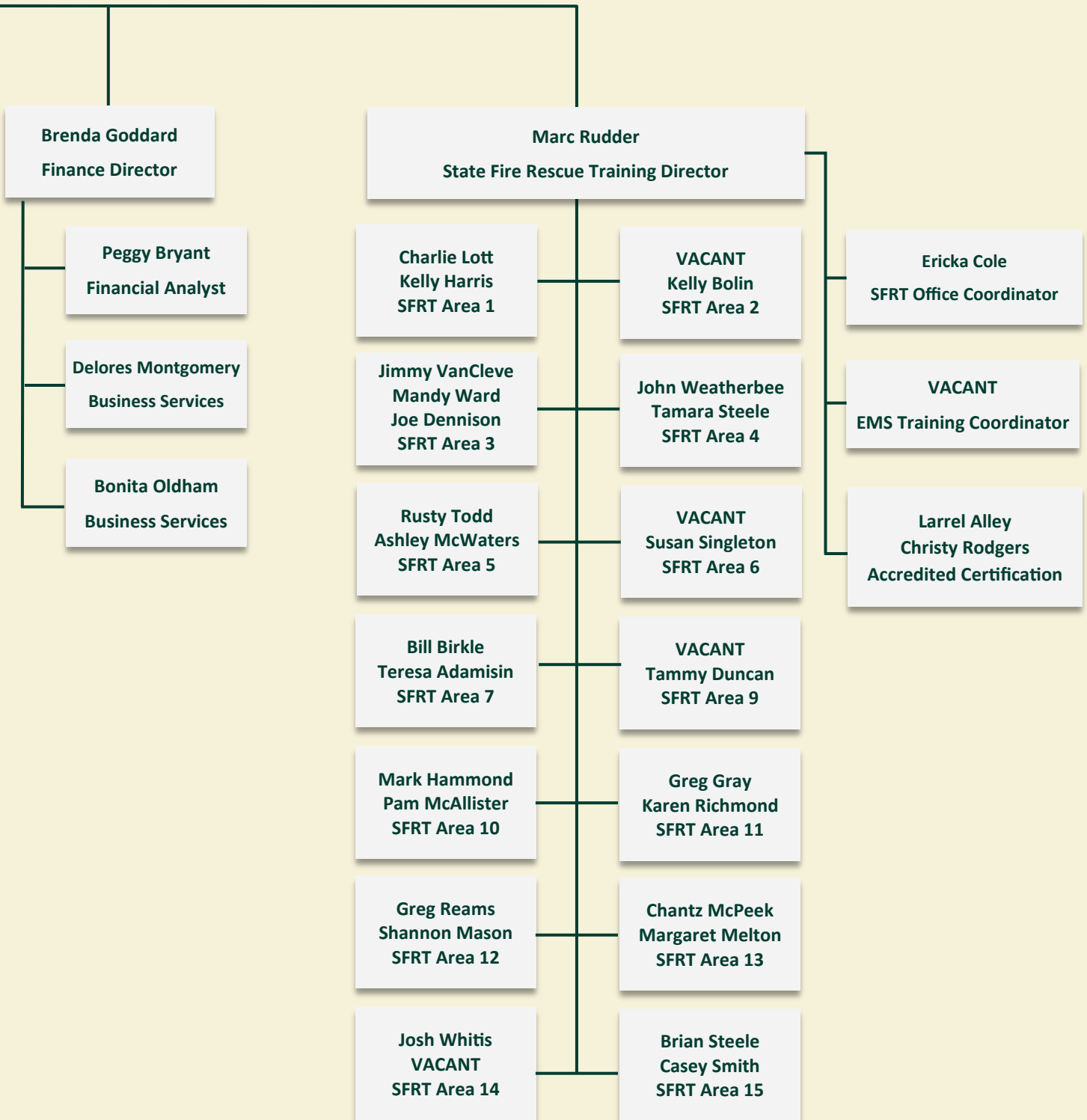

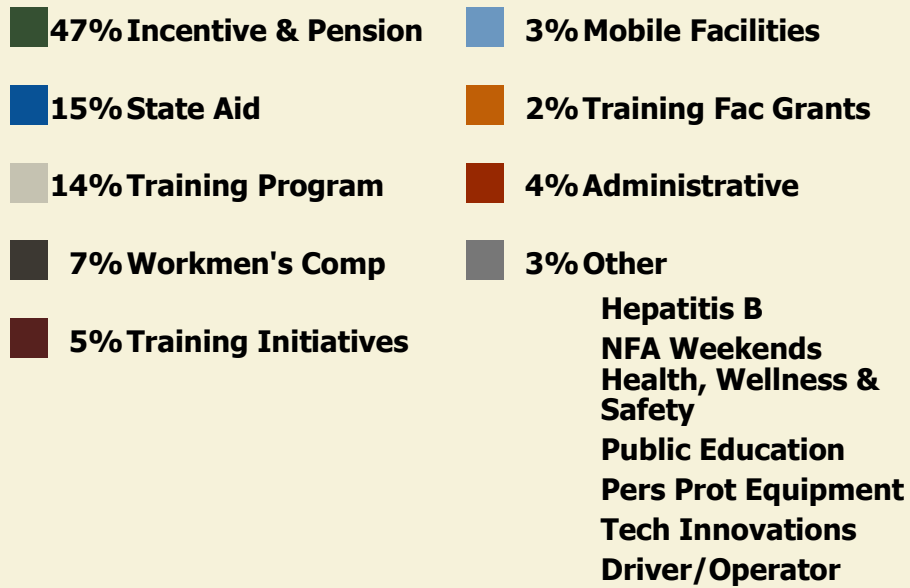

BUDGETARY



LEGISLATIVE

During the 2020 Kentucky Legislative Session, representatives of Kentucky's fire service and the Kentucky Fire Commission continued their efforts to educate legislators and protect the interests of the Kentucky's fire service. Despite the outbreak of COVID-19 shortening the 2020 Kentucky Legislative session, several bills related to the fire service were passed through Committee and were ultimately passed into law:

SB5

This act reviewed the fee and tax increase requirements by consolidated local governments and exemption of all Fire Taxing Districts.

SB111

This act related to transportation of police officers, firefighters and emergency medical services personnel killed in the line of duty.

SB249

This act froze the CERS employer rate phase-in for one year.

HB271

This act amended KRS 16.601 and 61.621 to remove provisions which reduce line of duty or duty-related benefits upon remarriage.

HB352

This act related to the State/Executive Branch budget and also froze pension rates.

HB375

This act related to reorganization of the membership of the Kentucky Fire Commission Board.

HB479

This act related to police and firefighter retirement funds of urban-county governments.

HB484

This act related to CERS pension separation and creation of a new CERS board.

NFA TRAINING WEEKEND

44 instructors with State Fire Rescue Training participated in the 2019 Kentucky In-State Weekend at the National Fire Academy in Emmitsburg, MD. Students selected from 7 courses, allowing personnel to bring this professional development material back to students across the Commonwealth:

JUNIOR FIREFIGHTER CAMPS

The Fire Commission hosted two junior firefighter camps in FY2020. Camps were offered in London and Greenville, allowing the Fire Commission to reach an extended population of junior firefighters who might otherwise be unable to attend a camp held in a single location.

These camps allow participants to enhance their skills in various fireground operations, learn to function as a team and network with junior firefighters from across Kentucky. In an effort to mimic real-life responses, training is conducted day and night in all types of weather conditions.

The fall camp was again held in November at the J.M. Feltner Memorial 4H Camp. 55 juniors from 33 departments spent three days training on rescue operations including heavy lifting and moving, trench rescue and large animal technical rescue.



The spring edition of junior firefighter camp was hosted in Greenville by the National Responder Preparedness Center and Wendell H. Ford Regional Training Center. 63 juniors from 35 departments spent the weekend focusing on live-fire operations training including hose and nozzle usage, gases/flammable liquid fires and helicopter fires.

To date, there have been 332 individual campers from 94 departments. 79 of these campers have participated in multiple camps, including three campers who have attended every camp they have been eligible to attend prior to aging out.



STATE FIRE SCHOOL

The 2020 edition of the Kentucky State Fire School was cancelled due to the ongoing COVID-19 situation.

INCENTIVE & PENSION

The Incentive & Pension fund continues to supplement eligible local governments, plus an amount equal to the required employers contribution on the supplement to the defined benefit pension plan, or to a plan qualified under Section 401(1) or Section 457 of the Internal Revenue Code of 1954 as amended.

To be eligible for incentive pay, firefighters must have a minimum of 400 training hours, work at least 2,080 hours and earn at least \$8,000 annually. To maintain eligibility, all firefighters in the department must complete 100 hours of training annually. Eligible firefighters receive \$4,000 per year through this program.

Due to COVID-19, temporary changes were made to the Incentive Pay requirements. These changes allowed for new career firefighter hires who possessed a current CPAT card and had completed all training toward their 400-hour Kentucky certification, with the exception of Fire Commission classes (Firefighter Survival, Firefighter Rescue, Wildland and Flashover), to be eligible to receive Incentive Pay until resumption of normal Fire Commission/SFRT training operations.

HEPATITIS VACCINATIONS

During FY2020, the Fire Commission's voluntary Hepatitis vaccination program assisted in providing funds for 94 firefighters to receive immunizations. With new legislation passed during the 2019 session, the Fire Commission now sponsors Hepatitis A, Hepatitis B or a combination of both Hepatitis A/B vaccines for Kentucky's firefighters.

THERMAL IMAGING CAMERA GRANTS

It is the goal of the Kentucky Fire Commission to make sure every department throughout the Commonwealth has at least one thermal imaging camera. 137 departments were awarded grant monies for reimbursement of thermal imaging camera purchases in FY2020.

TRAINING FACILITY GRANTS

The Fire Commission's Training Facility Grants program allows eligible and approved fire departments access to much needed funds to enhance their department's training program with facilities and equipment. This grant is offered every other year.

During FY2020, 28 departments were awarded grants totaling \$999,371.



FIRE DEPARTMENT AUDITS—TRAINING RECORDS

The Fire Commission continues to audit records of all departments for training hours compliance to ensure proper disbursement of both Incentive Pay and State Aid funds.

The Fire Commission's team of three auditors performed 101 departmental audits in FY2020. Many audits were unable to be completed due to the COVID-19 situation, and those remaining FY2020 departments will be rolled into the FY2021 audit cycle.

Audits are conducted by SFRT region.

LOW INTEREST LOANS

The Low Interest Loan program is available for any volunteer fire department that meets certain criteria. Volunteer fire departments can borrow up to (\$75,000) or (75%) of the total cost of the project, whichever is less. Funds in the amount of \$130,690 were distributed to three departments in FY2020.

STATE AID

The Fire Commission's State Aid program is available to all qualifying volunteer fire departments in the Commonwealth of Kentucky. The Kentucky Fire Commission allots \$11,000 on an annual basis to each qualifying volunteer fire department in cities of all classes.

In FY2020, 667 departments were awarded State Aid for a total of \$7,197,500. Monies must be allocated toward specific expenditures approved by the Fire Commission.

Funds are required to be spent in total each fiscal year. Departments may hold the entirety of the funds over into the following fiscal year to acquire enough funds for a more substantial project. Partial carryover is disallowed.

Funds may also be applied toward Fire Commission loan payments.



HEALTH & WELLNESS

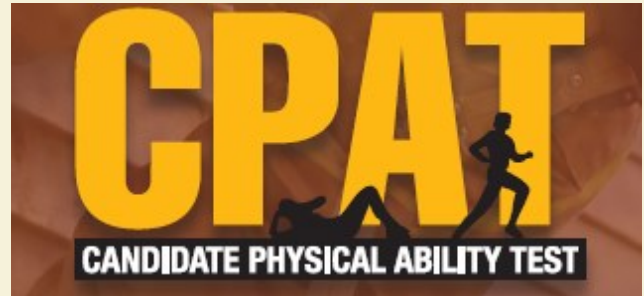
Cancer Awareness

In efforts to continue to raise awareness of cancer among firefighters and promote prevention of firefighter-related cancers, the Fire Commission placed gear extractors in 19 of the Commonwealth's fire departments during FY2020. These specialized washing machines allow carcinogens to be lifted and removed during the cleaning process while maintaining the safety and integrity of the turnout gear fabric and components.

CPAT

Since 2013, administrative regulations in the state of Kentucky mandate all newly hired career firefighters pass the Candidate Physical Ability Test (CPAT). CPAT is set up to develop a fair and valid evaluation tool in the selection of firefighters to ensure that all firefighter candidates possess the physical ability to complete critical tasks effectively and safely. CPAT is a sequence of events requiring the participant to progress along a predetermined path from event to event in a continuous manner. Stations include: Stair Climb, Hose Drag, Equipment Carry, Ladder Raise and Extension, Forcible Entry, Search, Rescue and Ceiling Breach and Pull.

Several testing sessions were cancelled in FY2020 due to COVID-19, and temporary changes to the CPAT mandate were enacted to ensure fire departments continued to be able to hire critical personnel during this time.

SMOKE DETECTOR GRANT

The Fire Commission purchased 3,174 smoke detectors for distribution to requesting Kentucky fire departments in FY2020. Departments then installed the detectors into local homes as part of their public education campaigns.

Development of a new records information system continued in FY2020. The Fire Commission worked with Bloomington, IN-based Envisage Technologies to create a new, more streamlined and user friendly training records tracking and management system to maximize efficiency, save money and simplify records input and information communication.

The Kentucky Fire Information and Records Entry System (KyFIRES) is a highly secure and comprehensive web-based training and compliance management system that will support the entire hire-to-retire lifecycle to ensure that each firefighter remains in compliance with Kentucky certification requirements. KyFIRES will also allow firefighters throughout the state to securely access their own training and certification records through any modern web browser.

In addition, KyFIRES will provide automated digital tracking of annual training required of career and volunteer firefighters, be a comprehensive portal for fire department support programs offered by the Fire Commission and provide a means to effectively communicate information to departments and firefighters in a timely manner.

Pilot group testing of the new system began in February, with the anticipation of going live in April. However, due to COVID-19, KyFIRES user training was halted until June. Soft rollout of KyFIRES is scheduled to begin in early FY2021, with full live implementation by the 2nd quarter of FY2021.

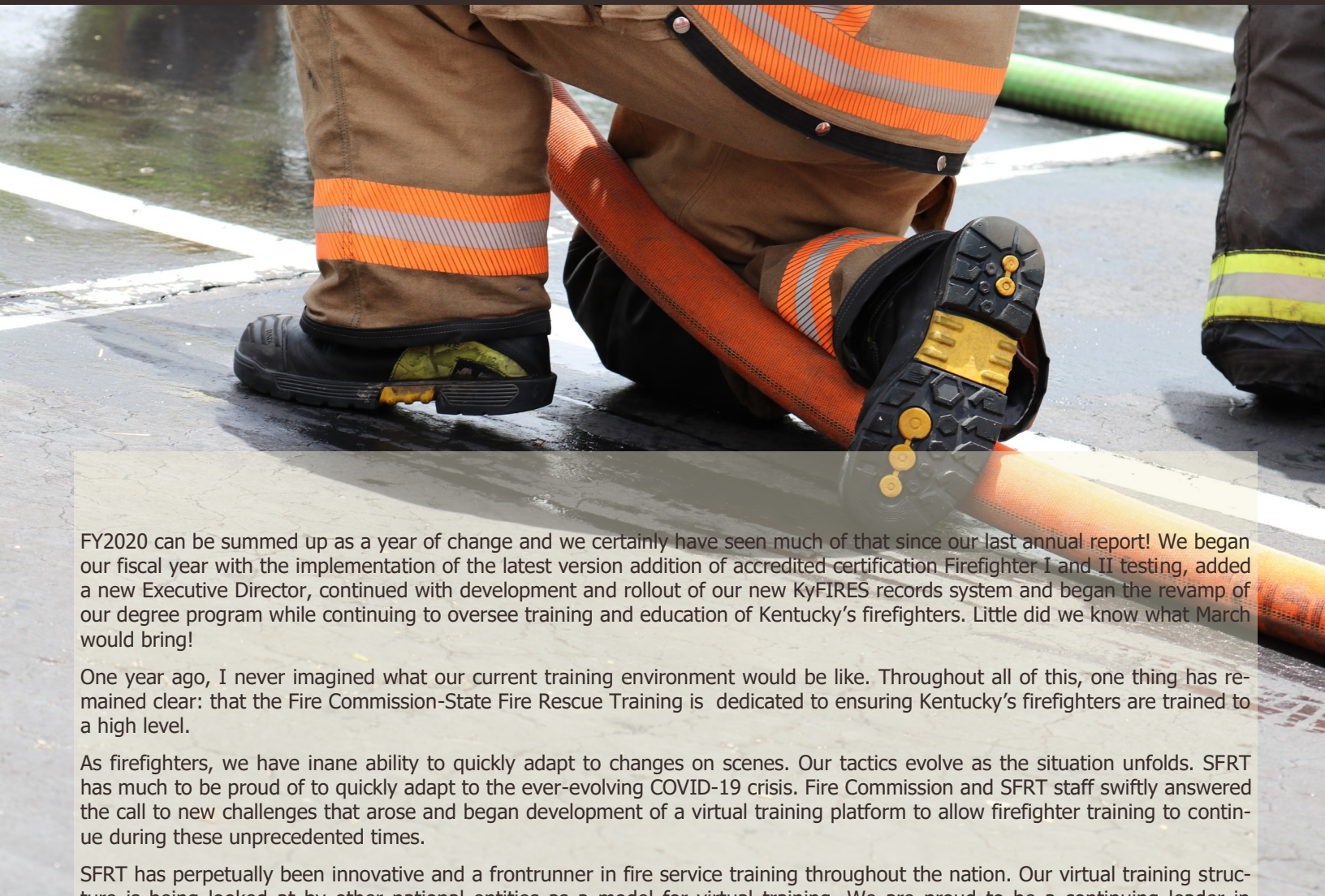
MISSION STATEMENT

Following Governor Beshear's recommendations on group gatherings, we are looking forward to once again engaging in face-to-face training in Kentucky's departments. We have received much positive feedback about our virtual trainings, and it is our intention to continue with it on a smaller scale.

FY2020 has brought many challenges to the fire service worldwide. We continue to focus on our mission of ensuring Kentucky's firefighters have the best training possible. Our mobile fleet is well equipped and we are dedicated to keep procuring the latest in training props to maintain our high quality of training delivery. We are excited about our new Fire Science Technology curriculum and believe this will be an excellent pathway for more of our firefighters to achieve their goals of a college degree on a custom level. We anticipate full implementation beginning with the Fall 2020 semester.

As we look ahead to FY2021 we know there will be further challenges and we at State Fire Rescue Training are ready to meet those challenges. It is my honor to lead the team of men and women who are so devoted and have a collective total of thousands of years of experience serving their community.

VIRTUAL TRAINING



Due to complexities surrounding the onset of COVID-19, the Fire Commission and State Fire Rescue Training withdrew from face-to-face training in March.

In early April SFRT amended methods used to deliver training to fire departments. In-person training was then moved to a Virtual Instructor-Led Training (VILT) platform.

VILT classes are led by an instructor in real-time, thereby allowing firefighters to utilize this type of training to assist toward completion of their 150- and 400-hour certifications while still adhering to administrative regulations that require face-to-face training for initial certification hours. Certified firefighters were also able to use VILT as it was set up for their annual continuing education requirements.

Implementing the virtual platform was an ever-evolving process which required administration, instructional staff and students to adapt swiftly to new procedures as they were put in place to ensure smooth delivery of this program.

The VILT program received much positive feedback and SFRT is working to continue offering trainings via this platform in the future.

From April 10-June 30, VILT served 24,570 students via 788 classes.

OPIOID EXPOSURE FOR FIRE RESPONDERS PROGRAM



During FY2020, the Fire Commission-State Fire Rescue Training enacted into a partnership grant with the University of Kentucky Injury Prevention Center to educate first responders on the risks of opioid exposure, when and what personal protective equipment to wear and how to treat themselves, fellow first responders and the public in the case of an accidental overdose of opioids.

The Fire Commission's Industrial Training Program provided this critical training to 826 students during 62 classes.

The degree, certificate and diploma programs that are offered can help in obtaining employment in various emergency service fields, or if already a firefighter, help assist in promotional opportunities. The program may be continued as a 2+2 program with Western Kentucky University's Systems Management Program.

Academic certificates are also available for Emergency Medical Technician, Basic Firefighter, Advanced Firefighter and Fire Officer. A Fire Chief diploma is offered as well.

Approximately 368 Certificates, Diplomas, and Degrees were awarded to students completing in 2019-2020.

Kentucky recognizes the International Fire Service Accreditation Congress (IFSAC) as its certification board. In addition to its certificate program, IFSAC also provides governing for the Fire Commission/State Fire Rescue Training's Fire-Rescue Science Technology degree program.

IFSAC accreditation is based on a peer-review process. During FY2020, Fire Commission employees participated in six site visits to review each entity's IFSAC program. Contingents also traveled to the fall IFSAC conference during FY2020. Both the accreditation and degree program certifications will be valid through 2023, at which time both programs must be reviewed and reaccredited again.

The Fire Commission updated their Firefighter I & II and Hazmat Awareness & Operations written and skills testings in FY2020 to align with new national standards.

Written tests are administered monthly in each area office as well as by appointment at the SFRT Area 9 office. 957 seals were issued from 771 written tests. 54 skills testing sessions were offered across the state during FY2020, with 783 candidates. 12 skills testing sessions were cancelled due to the novel coronavirus outbreak.

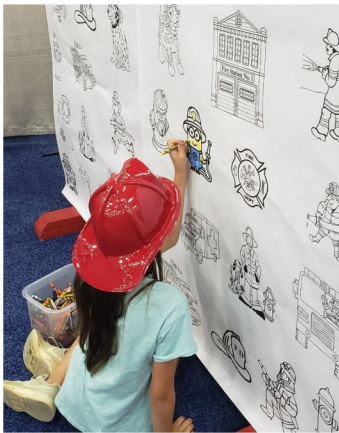
