COURSE DESCRIPTIONS

(1) EMT REFRESHER

This is a three-day course taught on Friday, Saturday, and Sunday that will cover all training requirements as set forth by the Kentucky Board of Emergency Medical Services (KBEMS) and the National Registry of EMT's for the 24-hour EMT Refresher Class/NCCP and incorporate both lecture and practical experience, including competency testing. Sponsored by Air EVAC

Friday-1:00 p.m. - 9:00 p.m.

Saturday- 8:30 a.m. - 5:00 p.m.

Sunday- 8:30 a.m. - 5:00 p.m. Instructors - Air Evac Staff

(2) HAZMAT AWARENESS – HazMat Ice Cream

This 4-hour training program addresses Awareness Level response for Hazardous Material from IFSTA. This class will each the student to use various hazardous material handbooks to Identify a hazardous incident. This class is a pre-requisite for attending the Hazmat Operations class on Friday and Saturday.

(3) HAZMAT OPERATIONS

This is a two-day hands-on class taught on Saturday and Sunday. You must have attended the Hazmat Awareness class taught on Friday evening (Oct. 20th) or other approved class to attend. This class addresses Operations Level response for Hazardous Material from IFSTA. This class will take the student from hazardous incident recognition through setting up a decontamination line. Equipment needed: Bunker gear, SCBA and spare cylinder.

(4) EXTRICATION

This class will begin with a short lecture to familiarize the student with extrication tools and principles. The class will practice cutting techniques on small to large vehicles and will have some technical scenarios to work through. This class will provide the students the opportunity to assess, plan, and implement extrication strategies in a variety of situations including passenger vehicles and larger commercial vehicles. **Friday- 6:00 p.m. -10:00 p.m.**

(5) WILDLAND AWARENESS

Kentucky Mandatory 3-hour Wildland Firefighting Awareness class developed for Kentucky Firefighters seeking certification by the Kentucky Fire Commission. Case histories will be presented in the program so we may learn how to keep from repeating the mistakes made in other tragic events.

(6) LIVE FIRE - ENGINE COMPANY OPS

As a member of an engine company, there are specific skills we must master. This hands-on course will go in-depth on three of those skills, stretching hose lines, knowing your proper flows, and efficient water application. When it comes to stretching hand lines, we only get one chance to get it right. This portion will cover hose line deployment, extending lines, and difficult stretches such as obstacles and overcoming common stretching issues. Students will have multiple repetitions on each of these. Knowing your flow will be the second skill station. We must know how to match our hose to the proper nozzle. Students will flow different sizes and types of nozzles for handlines. Efficient application of water inside a fire is more important now than it has ever been. This portion of the course will cover water mapping, interior stream angles, and coordinated fire attack, while using a new Live Fire Training Prop. This program is for all experience levels in the fire service. **PRE-REQUISITES/EQUIPMENT NEEDED: Prior completion of subjects listed on the Live Fire Course Competency Validation form. This form must be completed and brought to class. Full PPE & SCBA with a spare cylinder is required. All PPE must be less than 10 years old and SCBA cylinders within hydrostatic test date. Any student with facial hair that impedes the seal of the face piece will not be allowed to participate.

(7) SWIFTWATER AWARENESS

The course is appropriate for any emergency responder (Fire Service, Law Enforcement, EMS and Public Works.) that could find themselves within 10 feet of the water's edge during a swiftwater or flood incident. Swiftwater is defined by the National Fire Protection Association (NFPA) as water moving at a rate that exceeds one knot or approximately 1.15 miles per hour (mph). By comparison, the average walking pace is 3.3 mph. This course reviews proper safety at a swiftwater incident and how responders can safely stay away from the hazards that such incidents pose to citizens and emergency responders. Participants will learn the importance of scene safety and management, and general hazards. This course teaches all the knowledge and skills required to perform at the Awareness level according to NFPA 1670. Friday – 6:00. p.m. – 10:00 p.m.

(8) GRAIN RESCUE EMERGENCIES

Grain Emergencies claim the lives of several every year. While we watch the news and see where a fire department or rescue company work to rescue or recover an individual, we may not fully understand the complexity of the operations and the specialized equipment required to perform those operations. This class will provide the opportunity to get in the grain with a simulated emergency and perform the steps to free the person utilizing a grain rescue tube. Instructors will show several options of grain rescue tubes and each will be available to use in the grain.

Safety Equipment Required: Goggles, Gloves and Head protection.

(9) PUMP OPERATIONS

Pumper Operations and Theory will allow the firefighter to learn competency in the performance requirements necessary to perform the duties of a pumper operator. Basic preventive maintenance, pump operation, hydraulic calculations, relay pumping, and pump testing will be covered. Students will execute these skills through hands on training involving a front -line pumper.

Equipment needed: Bunker gear suggested, PPE minimum-boots and gloves.

(10) WATER SUPPLY

This course is designed for fire department personnel who utilize mobile water supply operations. Students will familiarize themselves with various alternative water sources and the equipment that is necessary to make use of those sources. Students will also discuss the need to pre-plan mobile water supply operations. Upon successful completion of this class, the student will learn how to make more efficient use of their department's equipment. Equipment needed: Bunker gear suggested, PPE minimum - boots and gloves.

(11) BASIC FIREFIGHTER SKILLS

Students will be given some basic firefighting knowledge and practicing skills necessary to begin a long and safe life of fire suppression. NOTE: This class has an optional session Friday from 6:00 PM until 10:00 PM. Students attending ALL sessions will complete the 20 training hours recommended by the Kentucky Fire Commission before emergency response activity.

(12) MACHINERY RESCUE

Have you ever received a call for a subject stuck in an HVAC vent, a wedding ring stuck on a finger, or even a motorcycle accident victim impaled on a signpost? The rescuer often finds difficulty in approaching these situations simply because of the unknowns. This class will bring a new perspective to this type of incident. Instructors will provide "out of the box" ways of thinking that are usually not incorporated with normal fire service operations. This different train of thought will help the student develop a framework of techniques and tools that will make this operation smooth and safe. At the end of this class the student will be confident in proper tool choice for these incidents and able to operate with confidence on scene. This class focuses upon hands-on training using many different types of cutting tools to complete extrication scenarios.

Equipment needed: Safety glasses, helmet, turnout coat and work gloves.

(13) FF SURVIVAL & RESCUE

The Kentucky Fire Commission mandates that ALL firefighters need to attend the Firefighter Survival & Rescue course to attain certification as a firefighter in KY. The Firefighter Survival course is the first segment of this training course and is intended to illustrate to the student the procedures to implement and follow to save oneself in the event of a catastrophic event on the fireground. The Firefighter Rescue is the second segment of this course and is intended to train the firefighter how to work to rescue someone else in the event of a bad situation on the fireground. Firefighter Survival will be offered on Saturday and Firefighter Rescue will be offered on Sunday. This is a two-day class offered on Saturday and Sunday. Junior firefighters are welcome in this class but must provide completed Jr. FF Program Training Form and Emergency Contact Information form prior to participation in class. You can contact our SFRT 9 office for these forms.

Equipment needed: Full protective clothing & SCBA required.

(14) KY FIRE INSPECTOR I

This class is the first step in the fire marshal's Fire Inspector Certification Program This class is the first step in the fire marshal's Fire Inspector Certification Program. Fire and building code officials will benefit from this course. This class provides instruction based on the 2012 NFPA fire codes, the Kentucky Standards of Safety (815 KAR 10:060) and the Kentucky Building Code (KBC). Building code officials learn basic principles of a fire inspection program and how it relates to the KBC. This class consists of two days of instruction followed by an exam.

Students are encouraged to bring a calculator and the currently adopted NFPA 101 (Life Safety Code) and NFPA 1 (Fire Code).

Class limited to 30 students.

(15) FIRE INSPECTOR II

This class is the second step in the fire marshal's revised Inspector Certification Program. This class is designed for fire inspectors and building code officials who deal with more difficult life, safety and building safety issues daily. Students will get detailed instruction on all use group requirements, design occupant load, and seating arrangements. This class consists of instruction. followed by an exam. Students are encouraged to bring a calculator. Prerequisite: Completion of KY Fire Inspector I for 6 months.

Class is limited to 30 students.

(16) FIRE CHIEF'S UPDATE - FIRE CHIEF'S ROUNDTABLE DISCUSSION

(17) TRAFFIC INCIDENT MANAGEMENT

Kentucky's Traffic Incident Management (TIM) training program addresses the challenges of moving people and goods efficiently and safely on the nation's highways. The Program focuses on response efforts that protect motorists and responders while minimizing the impact on traffic flow. TIM efforts include detecting, verifying and responding to incidents; clearing the incident scene; and restoring traffic flow. Based on the severity or type of incident, first responders may represent law enforcement, fire, transportation, emergency medical services, public safety, towing and recovery, public works and hazardous materials (HAZMAT) disciplines. Using a multiple discipline perspective, first responders will learn how to operate more efficiently and collectively. The training covers many topics including recommended TIM procedures and techniques.

(18) FLASHOVER AWARENESS

This 3-hour class is designed to deliver the minimum requirement for the 150-hour certification. During this class, the student will learn the indicators, both internal and external, of an impending flashover or backdraft situation and tactics to reduce the risks. This class will be lecture only. Friday 6:00p.m. – 9:00p.m. Instructor – SFRT 9 Staff

(19) KY BASIC SEARCH AND RESCUE

This course is designed to provide guidance to SAR field responders on the best practices and techniques. Information about the duties and tasks of SAR field responders, current information on SAR field responder clothing and equipment, as well as details on the latest search techniques, information on SAR specialists such as hasty search, grid search, utilizing specialty teams, subject packaging, and transport. There will be a search on Saturday evening. **PRE-REQUISITES/EQUIPMENT NEEDED:

All students must have water, two flashlights, sturdy shoes (no tennis shoes) and appropriate clothing for exercise. If you have a SAR pack, please bring for the exercise. Pencil and paper required. Friday - 6:00pm – 10:00pm Saturday - 8:00am – 6:00pm

(20) In Honor of the Charleston 9: A study of Change Following Tragedy

On June 18, 2007, nine firefighters perished in a furniture warehouse fire in Charleston, South Carolina. The engineer of the first-arriving engine, David, relates how this experience has changed organizational culture, response, education, and training on an international level. David gives a riveting account of what he witnessed that day, and the crisis the ensued in the fire service and his personal life as well.

Also included in this powerful program is David's research on organizational crisis and how an organization can utilize organizational learning to improve. Attendees will share in not only the pain of this occurrence, but also the triumph reflected in changes in numerous aspects of organizational culture. This course has been taught at over 600 organizations internationally, including private industry, public service, for profit and non-profit organizations. While this is a course regarding a fire service event, it is relatable to all organizations.

Special Guest Speaker

Dr. David Griffin

Charleston, South Carolina native, David Griffin (42) was the driver of the first engine to respond to the disastrous 2007 Sofa Super Store fire that claimed the lives of nine of his fellow firefighters. Plagued with survivor's guilt, he numbed himself with alcohol, painkillers, and blood sports so much so that it nearly cost him his life.

A turning point came in the days following a match with nationally ranked mixed-martial arts contender Houston "The Assassin" Alexander. For three days, he sat in darkness, his eyes swelled shut from the battering to his face. He asked himself how his lifestyle honored the nine who were dead.

"One can only sit around for so long and feel sorry for themselves until they have to get up and do something," Griffin said.

Now, Griffin has completed a Doctorate of Education in organizational leadership and development, training organizations across the globe on the importance of moving away from "the way we've always done it" mentality. He speaks about the Sofa Super Store fire and has helped with massive reforms in how firefighters are trained as well as how executives lead their teams. Griffin has dedicated his life to spreading the message of change to all types of organizations.

In consideration of the Kentucky Community and Technical College System ("KCTCS") Kentucky Fire Commission State Fire Rescue Training (referred to hereafter as "SFRT") allowing me to participate in this emergency service training class, I represent and agree as follows:

1. <u>Assumption of Risk.</u> I understand and acknowledge that the very nature of the training is dangerous and there are certain inherent risks associated with participating in the training, including but not limited to fire-related risks. I understand that the specific risks vary, but that they include injury, loss, or damage to myself or my property, or death, resulting from exposure to fire and unsafe conditions. I understand that efforts will be made by the instructional staff to create a working environment that is as safe as possible, and that the instructional staff will give me careful and prudent instruction in the operation of equipment and how to perform each task. However, I also understand that neither KCTCS nor SFRT – nor their respective boards, officers, agents, or employees – has control over these inherent risks, and that the risks cannot be eliminated completely regardless of the care taken by KCTCS or SFRT. By signing below, I represent that I appreciate the risks. I accept and voluntarily assume all risks that may arise from or in connection with my participation in the training. I understand that I am ultimately responsible for my own safety, and for my actions at all times.

2. <u>Participation</u>. I agree to perform only those activities specifically designated for the training, to follow all instructions and directions given to me by the instructional staff, and to adhere to all applicable safety standards. I will not participate in any activity that is not directly related to the training and class function, and I will ask for additional information before I proceed with a training procedure if I am unsure of the procedure or of the instructions and directions given.

3. <u>Workers' Compensation</u>. I understand that in order to participate in this training, I must be a member in good standing with a fire department or response agency, and I must be covered by the workers' compensation insurance of that department or agency. By signing this document, I certify that I meet these requirements. I understand that in the event of any accident or injury, any workers' compensation claim must be made under the coverage of my department or agency. In no event will I request workers' compensation coverage from KCTCS or SFRT and either KCTCS or SFRT will be responsible for any accident or injury.

4. <u>Release and Hold Harmless</u>. I understand that participating in the training may result in injury, loss, or damage to myself or my property, or death, and neither KCTCS or SFRT – nor their respective boards, officers, agents, or employees – will be responsible or liable for such injury, loss, damage, or death. By signing below, I release, hold harmless, and forever discharge KCTCS or SFRT – and their respective boards, officers, agents, and employees – from any and all claims, causes of action, or demands of every kind by reason of any injury to person or property, or death, arising from or in connection with my participation in this training.

5. <u>Alcohol and Medications</u>. I agree and represent that I will not consume alcoholic beverages or any prescription or non-prescription medications or other controlled substances that may impair my judgment or reaction time within the five (5) hours prior to any class, or during class.

6. <u>Live Fire</u>. I understand that this training involves live fire, I must have completed certain FF1 and FF2 job performing requirements, as set forth in NFPA 1001 and 1403 directives.

7. <u>Accident or Injury</u>. I agree and represent that in the event of any accident or injury, I will report such accident or injury IMMEDIATELY to the instructional staff. I will also report such accident or injury to the administrative officer of my fire department or response agency as soon as is reasonably practicable, but in no event more than 24 hours after the accident or injury.

By signing below, I agree that I have been given sufficient time to read, understand, and ask questions, if any, concerning the nature and scope of this Release. I understand that any breach of the above stated items could result in my immediate dismissal from class.

Live Fire Course Competency Validation/Fitness for Duty Form Required for all students before participating in SFRT Live Fire Training

NFPA 1403 (2018 Edition) 4.3.1 - 4.3.3 require that all participants must have prior training and meet prerequisites in certain subjects before participating in live fire training. These minimum subjects include:

Specific prerequisite training must also be met in these areas: Fire Dynamics; Health and Safety; Fundamentals of Fire Behavior; Fire Development in Compartments; Nozzle Techniques and Door Control.

training/prerequisites and may participate in the live fire training evolutions present by SFRT.

NFPA 1403 (2018 Edition) 4.4.1 requires that all participants must be rehabbed in accordance with NFPA 1584, Chapter 6. Before being released from the rehab area to participate in a State Fire Rescue Training live fire training evolution, normal conditions are considered to consist of: heart rate of 60-100; respiratory rate of 12-20; systolic blood pressure less than 160; diastolic blood pressure of less than 100; pulse oximetry of 95% or greater. Participants are encouraged to periodically check their vital signs and seek appropriate medical attention for abnormal signs/symptoms.

Participants must be a member of a Fire Department, Industrial Fire Brigade or Junior Firefighter program (Ages 15-17) that is recognized by the Kentucky Fire Commission to participate in live fire training delivered by State Fire Rescue Training. ID's will be checked by SFRT instructors before allowing students to participate in live fire training and some evolutions/activities are restricted for 15-17 year old Junior Firefighters (See current Junior Firefighter Guidelines on KY Fire Commission website.) All turnout gear must be less than 10 years of age. Per NFPA 1403 (2018 Edition) A4.9.5 it is recommended that all participants wear full-length clothing made of natural fibers or fire-retardant materials under their personal protective equipment during live fire evolutions.

Facepiece seal protection: SFRT requires that all students must be compliant with OSHA 29 CFR 1910.134: "<u>1910.134(g)(1)(i)</u>-The employer shall not permit respirators with tight-fitting facepieces to be worn by employees who have: <u>1910.134(g)(1)(i)(A)</u>- Facial hair that comes between the sealing surface of the facepiece and the face or that interferes with valve function;" (hair growth between the skin and the facepiece sealing surface, such as stubble beard growth, beard, mustache or sideburns which cross the respirator sealing surface).
