1. ESSENTIALS OF FIREFIGHTING / BASIC 20 Hours

This class will explore the basic skills every firefighter needs to know. This class will benefit new firefighters as well as seasoned veterans. The subjects taught will follow the Kentucky Fire Commission's recommended initial 20 hour list. Subjects will include administration & organization – 2, safety – 2, fire behavior – 1, extinguishers – 1, personal protective equipment – 3, forcible entry – 1, ventilation – 1, ropes – 1, ladders – 2, fire hose, nozzles & appliances – 2, fire control – 1, loss control – 2, driver training – 1. This class will include both classroom presentations and hands on evolutions. This class will begin on Friday evening at 6:00pm. Students may elect to attend Friday, Saturday or Sunday sessions.

2. EMT CONTINUING EDUCATION

The Kentucky Board of Emergency Medical Services has drafted the new regulations and should become effective on January 01, 2022. With this change, all KY providers must follow the NCCP for their CEUs. The NREMT EMT NCCP model takes the requirements from 72 hours to 40 hours every two years. For the EMT level, there are 20 mandated hours identified by NREMT, 10 hours identified by your local jurisdiction and 10 hours identified by yourself. This course will provide the 20 mandated hours identified by the NREMT for EMT NCCP refresher training. This training will cover the topics for the EMR providers as well.

3. FIREFIGHTER SURVIVAL & RESCUE

The Kentucky Fire Commission mandates that ALL firefighters need to attend the Firefighter Survival & Rescue course to attain certification as a firefighter in KY. The Firefighter Survival course is the first segment of this training course and is intended to illustrate to the student the procedures to implement and follow to save oneself in the event of a catastrophic event on the fireground. The Firefighter Rescue is the second segment of this course and is intended to train the firefighter how to work to rescue someone else in the event of a bad situation on the fireground. Firefighter Survival will be offered on Saturday and Firefighter Rescue will be offered on Sunday.

Successful completion of both segments will enable the student to receive 1.1 credit hours in the FRS 2052 Firefighter Survival and Rescue category of the Fire/Science Degree program.

4. Modern Vehicle Rescue

This class will begin with a short lecture to familiarize the student with extrication tools and principles. The class will travel to an off-site location to practice cutting techniques on small to large vehicles and also will have some technical scenarios to work through. This class will provide the students the opportunity to assess, plan, and implement extrication strategies in a variety of situations including passenger vehicles and larger commercial vehicles. Students registering for this class should come prepared to work for two full days of activities. This class size is limited to 30 students.

5. FIRE BEHAVIOR – Max Fire Box and the new Phase II prop

This class will focus on Fire Behavior with a little classroom lecture covering Fire Behavior and Thermal Imaging Cameras. The class will use the Max Fire Box in the morning and will utilize the Phase II prop in the afternoon to study Flashovers, Smoke Explosions (Backdrafts), thermal layering, smoke patterns and heat travel/fire extension throughout the home. Turnout gear is not required for this class but if you have a thermal imaging camera that you could bring, this is a great class to learn some of the potential uses for the TIC while fighting a fire and reading a structure for fire extension.

6. FLASHOVER RECOGNITION and WILDLAND FIRE BEHAVIOR

The KY Fire Commission requires that all firefighters seeking certification will complete the 3-hour Flashover Recognition & Survival course as well as the 3-hour Wildland Fire Behavior course. Each of these courses were developed in Kentucky for the purpose of saving the lives of our firefighters. Both were updated in the past couple years and will make a great course for both the new firefighter as well as the seasoned veteran firefighter.

7. NFA STICO – (STRATEGY & TACTICS FOR INITIAL COMPANY OPERATIONS)

This two-day course is designed to meet the needs of Company Officers (COs) responsible for managing the operations of one or more companies during structural firefighting operations. This course is designed to develop the management skills needed by COs to accomplish assigned tactics at structure fires. This class is a part of the MTCO series.

8. HARD TO GET HOURS

This class is ideal for the firefighter that is almost certified but lacks just a few needed hours that are “hard to get”. This two-day class will offer the following course topics: Emergency & Disaster Planning (2), Communications (3), Fire Investigation (3), Fire Protection Systems (3), Aircraft (3), Foam (2).

9. HAZARDOUS MATERIALS AWARENESS and OPERATIONS

The Kentucky Fire Commission requires that a firefighter must have 8 hours of Haz-mat Awareness and 12 hours of Haz-mat Operations to become certified as a firefighter in Kentucky. This Haz-mat Awareness course will cover information necessary for any first responder whether in the fire service, EMS, law enforcement or other responding agency. Information covered will be consistent with NFPA 472 as well as 29 CFR 1910.120. The Hazardous Materials Awareness level trained individual may work outside of the danger zone, away from the incident, but may not participate in the activities in or around the 'hot zone'. The Haz-mat Operations course will provide the training that will enable the responder to respond to and function on a fireground involving hazardous materials but only in a defensive mode of operation.

10. BASIC ROPE RESCUE

This is a hands-on course that introduces students to technical rope rescues. This course covers the technical aspect of rope equipment, as well as: Practical applications of rappelling/lowering techniques, anchor systems, safety systems, and communications. Students will learn techniques for life-saving operations in the vertical environment, while maintaining an adequate level of safety for the rescuer and the patient. Techniques will include, rappels, lock-offs, inversions, belays, and working with litters. Students should come prepared to work.

THIS IS A TWO-DAY CLASS OFFERED ON SATURDAY and SUNDAY

Equipment Needed: Helmet with a suspension system and chin strap (Fire helmets, OK), lace-up boots with ankle support, clean leather gloves, eye protection, and a positive attitude with a desire to learn.

11. FIRE SCENE INVESTIGATIONS (Arson II)

This is a comprehensive course with emphasis on techniques to determine the origin and cause of fires. Actual case scenarios will be incorporated to enhance this class. A wide variety of expertise is brought together through the cooperation of local, state, federal, fire, police and private investigators to provide the student with excellent instruction and detail.

PRE-REQUISITES/EQUIPMENT NEEDED

Prior completion of an acceptable Arson I course. You must have a signed permission form or letter from your chief prior to attending fire investigation courses taught by the Kentucky Chapter IAAI.

THIS IS A TWO and ½ DAY CLASS OFFERED ON Friday, Saturday and Sunday

FULL PROTECTIVE CLOTHING & SCBA REQUIRED

This class will begin on campus and will travel to an off-site location for the investigative evolutions.

12. PUMP & DRIVE (Simulator Training)

This class will utilize the Kentucky Fire Commission's new Pump Operations Simulator as well as the Driver Training Simulator. This class will spend 4 hours on the pump simulator and the other 4 hours on the Driver Training Simulator. Students will get hands-on practice and experience driving to the scene and then get instructions on operating the fire pump from the panel, all simulation training. The instructor has the ability to 'build' your truck on the pump simulator and you can get real, hands-on practice pumping your truck with multiple lines, drafting or receiving water from a hydrant or another truck.

13. SLICE-RS / ACTIVE SHOOTER

Morning Session: PRINCIPLES of MODERN FIRE ATTACK: SLICE-RS

This class will provide a firsthand look at the UL/NIST Modern Fire Behavior/Dynamics studies and serve to educate students how they can be delivered and instituted in their fire departments. It is our hope that by compiling the best lessons learned from the fire dynamics research, fire departments will be able to adjust their policies, tactics and training to create a safer environment for the fire service as well as the people we serve in our communities. This information has been known to be controversial to some, so be prepared for great discussions. You don't have to look far for good discussion regarding fire command, control, accountability and especially fire behavior. The shared science, research and best practices are another tool for your toolbox! Go home to your department with a renewed outlook and with a healthy knowledge of the Principles of Modern Fire Attack: SLICE-RS.

Afternoon Session: ACTIVE SHOOTER / HOSTILE ENVIRONMENT RESPONSE

An increased number of active shooter events or Criminal Mass Casualty Incidents (C-MCI) have led to specific recommendations & guidelines for emergency response personnel. To improve functionality & interoperability between agencies Fire, EMS & law enforcement should: a) Establish & adopt joint response protocols and b) Integrate activities & participate in joint training exercises. This program is designed to introduce Tactical Emergency Casualty Care (TECC) principles & practices, describe pre-incident planning & establishing standard operating procedures, describe best response practices, demonstrate TECC skills, and demonstrate techniques for casualty evacuation. Target audience should include EMS responders, Fire Department Personnel, Emergency Management, Law Enforcement agencies, School Administrators, and Administrators of Places of Worship.

14. METHODOLOGY UPDATE / SUICIDE AWARENESS & PREVENTION

MOI Update: This 4 hour class, designed for Fire Service Instructors, introduces/refreshes the participant to basic instructional concepts and techniques. Emphasis is on teaching principles and techniques applicable to fire and rescue service training and includes effective communication, teaching from lesson plans, methods of instruction, with emphasis on skills training and adult learning. **This course meets one of the requirements for newly announced Fire Service Instructor recertification.**

Suicide Awareness and Prevention: We always stay alert to the dangers on the fireground whether downed powerlines, gas leaks, unstable structures and other obvious hazards. Seldom have we looked at the hidden dangers that may not affect us today, but in years to come. Suicide is rapidly becoming a leading cause of preventable deaths in the fire service but we first need to know the signs to look for and then what we can do to provide assistance to prevent this needless death.

15. PHTLS for First Responders

NEW PHTLS for First Responders – PHTLS-FR – Provider Course: PHTLS for First Responders (PHTLS-FR) is an 8-hour classroom course that takes the world-class trauma care content from the 9th edition of PHTLS and delivers it in a style that is relevant to and accessible by first responders, including emergency medical responders (EMR), firefighters, rescue personnel and law enforcement officers. Covering life-saving interventions such as hemorrhage control and airway management, this course teaches critical trauma concepts, demonstrates skills, and walks students through potential patient scenarios. Course materials include a student manual, providing students with access to these important concepts long after the course is over. Upon successful completion of this course, students receive a certificate of completion, a wallet card good for 4 years and 8 hours of CAPCE credit.

** There will be an additional \$15.00 charge for this course to cover the student manual and course completion card.

16. BLS-O (Basic Life Support for Obstetrics)

Basic Life Support in Obstetrics (BLSO) offers evidence-based, hands-on training that promotes teamwork and helps you manage both normal labor and perinatal emergencies. The BLSO Provider Course is designed for pre-hospital maternity care providers such as emergency department personnel and first responders. It serves as a great beginner level obstetrical training.

Participants attending a BLSO Course learn practical, standardized team-based approaches to managing both a normal labor scenario as well as obstetrical emergencies. Although labor and delivery room emergency care is the main focus of the program, the BLSO curriculum further addresses preventative care and practice concerns such as emergent prenatal assessment, malpresentations, preterm labor, and premature rupture of membranes and neonatal resuscitation.

In consideration of the Kentucky Community and Technical College System ("KCTCS") Kentucky Fire Commission State Fire Rescue Training (referred to hereafter as "SFRT") allowing me to participate in this emergency service training class, I represent and agree as follows:

1. Assumption of Risk. I understand and acknowledge that the very nature of the training is dangerous and there are certain inherent risks associated with participating in the training, including but not limited to fire-related risks. I understand that the specific risks vary, but that they include injury, loss, or damage to myself or my property, or death, resulting from exposure to fire and unsafe conditions. I understand that efforts will be made by the instructional staff to create a working environment that is as safe as possible, and that the instructional staff will give me careful and prudent instruction in the operation of equipment and how to perform each task. However, I also understand that neither KCTCS nor SFRT – nor their respective boards, officers, agents, or employees – has control over these inherent risks, and that the risks cannot be eliminated completely regardless of the care taken by KCTCS or SFRT. By signing below, I represent that I appreciate the risks. I accept and voluntarily assume all risks that may arise from or in connection with my participation in the training. I understand that I am ultimately responsible for my own safety, and for my actions at all times.

2. Participation. I agree to perform only those activities specifically designated for the training, to follow all instructions and directions given to me by the instructional staff, and to adhere to all applicable safety standards. I will not participate in any activity that is not directly related to the training and class function, and I will ask for additional information before I proceed with a training procedure if I am unsure of the procedure or of the instructions and directions given.

3. Workers' Compensation. I understand that in order to participate in this training, I must be a member in good standing with a fire department or response agency, and I must be covered by the workers' compensation insurance of that department or agency. By signing this document, I certify that I meet these requirements. I understand that in the event of any accident or injury, any workers' compensation claim must be made under the coverage of my department or agency. In no event will I request workers' compensation coverage from KCTCS or SFRT and either KCTCS or SFRT will be responsible for any accident or injury.

4. Release and Hold Harmless. I understand that participating in the training may result in injury, loss, or damage to myself or my property, or death, and neither KCTCS or SFRT – nor their respective boards, officers, agents, or employees – will be responsible or liable for such injury, loss, damage, or death. By signing below, I release, hold harmless, and forever discharge KCTCS or SFRT – and their respective boards, officers, agents, and employees – from any and all claims, causes of action, or demands of every kind by reason of any injury to person or property, or death, arising from or in connection with my participation in this training.

Live Fire Course Competency Validation/Fitness for Duty Form

Required for all students before participating in SFRT Live Fire Training

NFPA 1403 (2018 Edition) 4.3.1 - 4.3.3 require that all participants must have prior training and meet prerequisites in certain subjects before participating in live fire training. These minimum subjects include:

1) Safety; 2) Fire Behavior; 3) Portable Extinguishers; 4) Personal Protective Equipment & SCBA; 5) Ladders; 6) Fire Hose, Appliances, and Streams; 7) Overhaul; 8) Water Supply; 9) Ventilation; 10) Forcible Entry; 11) Building Construction. Specific prerequisite training must also be met in these areas: Fire Dynamics; Health and Safety; Fundamentals of Fire Behavior; Fire Development in Compartments; Nozzle Techniques and Door Control.

The Chief Officer of _____ Fire Department authorizes that _____ completed the minimum training/prerequisites and may participate in the live fire training evolutions present by SFRT.

NFPA 1403 (2018 Edition) 4.4.1 requires that all participants must be rehabbed in accordance with NFPA 1584, Chapter 6. Before being released from the rehab area to participate in a State Fire Rescue Training live fire training evolution, normal conditions are considered to consist of: heart rate of 60-100; respiratory rate of 12-20; systolic blood pressure less than 160; diastolic blood pressure of less than 100; pulse oximetry of 95% or greater. Participants are encouraged to periodically check their vital signs and seek appropriate medical attention for abnormal signs/symptoms.

Participants must be a member of a Fire Department, Industrial Fire Brigade or Junior Firefighter program (Ages 15-17) that is recognized by the Kentucky Fire Commission to participate in live fire training delivered by State Fire Rescue Training. ID's will be checked by SFRT instructors before allowing students to participate in live fire training and some evolutions/activities are restricted for 15-17 year old Junior Firefighters (See current Junior Firefighter Guidelines on KY Fire Commission website.) All turnout gear must be less than 10 years of age. Per NFPA 1403 (2018 Edition) A4.9.5 it is recommended that all participants wear full-length clothing made of natural fibers or fire-retardant materials under their personal protective equipment during live fire evolutions.

Facepiece seal protection: SFRT requires that all students must be compliant with OSHA 29 CFR 1910.134:

“[1910.134\(g\)\(1\)\(i\)](#) -The employer shall not permit respirators with tight-fitting facepieces to be worn by employees who have: [1910.134\(g\)\(1\)\(i\)\(A\)](#) - Facial hair that comes between the sealing surface of the facepiece and the face or that interferes with valve function;” (hair growth between the skin and the facepiece sealing surface, such as stubble beard growth, beard, mustache or sideburns which cross the respirator sealing surface).
