COURSE DESCRIPTIONS

1 - EMT REFRESHER

This is a three-day course taught on Friday, Saturday, and Sunday that will cover all training requirements as set forth by the Kentucky Board of Emergency Medical Services (KBEMS) and the National Registry of EMT's for the 24-hour EMT Refresher Class/NCCP and incorporate both lecture and practical experience, including competency testing.

Friday-1:00 p.m. - 9:00 p.m. Saturday- 8:30 a.m. - 5:00 p.m. Sunday- 8:30 a.m. - 5:00 p.m.

2 - INTRO TO FIRST RESPONDER & POLICE SOCIAL WORK

Ashley Messer, the city of Maysville's first Police Social Worker, will be presenting information pertaining to her new role and how it will benefit community members and first responders in the Maysville community. There will be a focus on the structure and makeup of co-response units and incorporating behavioral health professionals into emergency responses and crises. While this new role is rooted in the police department, co-response often involves fire/EMS professionals as well. Following this presentation, participants will be encouraged to engage in open dialogue regarding a range of topics relating to the field of emergency services and not only the social needs of patients/victims, but the needs of first responders themselves. Discussions may include mental health and well-being, peer-support, and self-care.

3 - WATER RESCUE - BOAT OPERATIONS

Water Rescue Boat Operator is a course will familiarize students with boat operations in the flood/Swift water environment. Students will be exposed to several topics including types of motorized boats suitable for water rescue, boat handling on still or slowly moving water, crew roles, boat safety and problem solving. Class will consist of both Classroom and Hands-on Skills.

Class V PFD and Clothing suitable for water operations

4 - VEHICLE EXTRICATION

This course will begin with a short lecture to familiarize the student with extrication tools and principles. The class will practice cutting techniques on small to large vehicles and will have some technical scenarios to work through. This course will provide the students the opportunity to assess, plan, and implement extrication strategies in a variety of situations including passenger vehicles and larger commercial vehicles.

5 - FIRE COMMISSION INFORMATION

This course will be moderated by KY Fire Commission Staff and will provide information on the current and future status and operations within the KY Fire Commission. This course will provide local agencies the opportunities to ask questions and gather information that will help with their day-to-day operations and future planning.

6 - LIVE FIRE - ENGINE COMPANY OPERATIONS

As a member of an engine company, there are specific skills we must master. This hands-on course will go indepth on three of those skills, stretching hose lines, knowing your proper flows, and efficient water application. When it comes to stretching hand lines, we only get one chance to get it right. This portion will cover hose line deployment, extending lines, and difficult stretches such as obstacles and overcoming common stretching issues. Students will have multiple repetitions on each of these. Knowing your flow will be the second skill station. We must know how to match our hose to the proper nozzle. Students will flow different sizes and types of nozzles for handlines. Efficient application of water inside a fire is more important now than it has ever been. This portion of the course will cover water mapping, interior stream angles, and coordinated fire attack, while using a new Live Fire Training Prop and MFD fixed training building. This program is for all experience levels in the Fire Service.

**Pre-Requisites/Equipment Needed: Full PPE including SCBA w/spare cylinder. Prior completion of Live Fire Course Competency Validation Form. No facial hair that impedes the seal of the SCBA Facepiece.

7 - SWIFTWATER AWARENESS

The course is appropriate for any emergency responder (Fire Service, Law Enforcement, EMS and Public Works.) that could find themselves within 10 feet of the water's edge during a swiftwater or flood incident. Swiftwater is defined by the National Fire Protection Association (NFPA) as water moving at a rate that exceeds one knot or approximately 1.15 miles per hour (mph). By comparison, the average walking pace is 3.3 mph. This course reviews proper safety at a swiftwater incident and how responders can safely stay away from the hazards that such incidents pose to citizens and emergency responders. Participants will learn the importance of scene safety and management, and general hazards. This course teaches all the knowledge and skills required to perform at the Awareness level according to NFPA 1670.

8 – ERI - SEARCH MANAGEMENT FOR INITIAL RESPONSE INCIDENT COMMANDER

This twenty (20) hour course meets the minimum search management training requirement specified in 106 KAR 1:390 for local search and rescue coordinators. The class is designed for individuals responsible for investigating reports of lost or overdue individuals, and for initiating appropriate search responses. It is designed to provide a systematic and logical method whereby incident commanders and managers can make rapid decisions on tactics and the application of resources. This course is open to all Emergency Management, Rescue, Fire, Emergency Medical, and Law Enforcement personnel or any organization having responsibility for searching for missing or lost persons. **Pre-Requisites/Equipment Needed: Completion of the twenty (20) hour Basic Search and Rescue Course (BSAR). A copy of your BSAR course completion certificate must be provided before the class.

9 - PUMP OPERATIONS

Pumper Operations and Theory will allow the firefighter to learn competency in the performance requirements necessary to perform the duties of a pumper operator. Basic preventive maintenance, pump operation, hydraulic calculations, relay pumping, and pump testing will be covered. Students will execute these skills through hands on training involving a front-line pumper.

**Pre-Requisites/Equipment Needed: Structural PPE suggested, PPE minimum-Boots, Gloves and Helmet Saturday- 8:30 a.m. - 5:00 p.m.

10 - WATER SUPPLY

This course is designed for fire department personnel who utilize mobile water supply operations. Students will familiarize themselves with various alternative water sources and the equipment that is necessary to make use of those sources. Students will also discuss the need to pre-plan mobile water supply operations. Upon successful completion of this class, the student will learn how to make more efficient use of their department's equipment.

11 - BASIC FIREFIGHTER SKILLS

Students will be given some basic firefighting knowledge and practicing skills necessary to begin a long and safe life of fire suppression. NOTE: This class has an optional session Friday from 6:00 PM until 10:00 PM. Students attending ALL sessions will complete the 20 training hours recommended by the Kentucky Fire Commission before emergency response activity.

12 - Bus Extrication & Electric Bus response

This specialized course is a two-day program that will provide each student with an in-depth understanding of rescue and extrication operations involving a school bus. Topics covered include school bus construction, scene safety and hazard control, incident command, and EMS considerations. Also, an electric powered school bus will be utilized to help with the understanding of basic electrical principles, common electrical components, and how to mitigate common hazards associated with electric powered buses.

**Pre-Requisites/Equipment Needed: Extrication/Structural PPE including Gloves and Eye Protection Saturday- 8:30 a.m. - 5:00 p.m.

13-KY FIRE INSPECTOR I

This class is the first step in the fire marshal's Fire Inspector Certification Program. Fire and building code officials will benefit from this course. This class provides instruction based on the 2012 NFPA fire codes, the Kentucky Standards of Safety (815 KAR 10:060) and the Kentucky Building Code (KBC). Building code officials learn basic principles of a fire inspection program and how it relates to the KBC. This class consists of two days of instruction followed by an exam.

**Pre-Requisites/Equipment Needed: Students are encouraged to bring a calculator and the currently adopted NFPA 101 (Life Safety Code) and NFPA 1 (Fire Code). Class limited to 30 students.

14 - KY FIRE INSPECTOR II

This class is the second step in the fire marshal's revised Inspector Certification Program. This class is designed for fire inspectors and building code officials who deal with more difficult life, safety and building safety issues daily. Students will get detailed instruction on all use group requirements, design occupant load, and seating arrangements. This class consists of instruction. followed by an exam. Students are encouraged to bring a calculator.

**Pre-Requisites/Equipment Needed: Completion

of KY Fire Inspector I for 6 months.

Class is limited to 30 students.

15 - LARGE ANIMAL RESCUE

Large Animal Rescue Operations is a 2-day operations level course that encompasses aspects of large animal technical rescue; and focuses on the ropes and rigging skills that may be applied in various situations. This large animal rescue training includes both hands-on and classroom instruction. The Large Animal Rescue Operations class includes practicing rescue scenarios, use of lift mechanisms and a Becker Sling and the use of a life-sized, weighted horse mannequin with articulating limbs.

**Pre-Requisites/Equipment Needed: Extrication/Structural PPE suggested, PPE minimum-Boots, Gloves and Helmet

16 - GRANT WRITING FOR FIRE DEPARTMENTS

This course educates fire and emergency services personnel on how to write a successful grant narrative in an effort to secure funding for their local fire/EMS department. Participants will also be introduced to a variety of funding opportunities, including government and private grants.

17 - SURVIVING THE MAYDAY - THE MEADOWOOD COURT INCIDENT - A COMPANY OFFICER'S PERSPECTIVE

On May 25th, 2008, while operating on a residential structure fire in Leesburg, Virginia, four firefighters from Loudoun County Fire and Rescue became trapped on the second floor while performing interior operations after conditions rapidly deteriorated. Four firefighters received burn injuries and required hospitalization. As the Engine Company Officer that day, I give an 'inside assessment' as to the actions of myself and my crew, to include lessons learned and personal development following the incident. A full investigative report was completed on this incident, and I will present incident operations, provide video footage of the incident with respective radio transmissions, our departmental changes/recommendations, and the lessons learned from the company officer's first-hand perspective. This presentation will also cover how training yourself and crew the right way becomes second nature and how you can rely on training when it truly counts. This incident has already been the subject of Firehouse Close Calls articles that was published and appeared in June & July 2009 by Chief William Goldfeder and has been published by Fire Engineering in May 2019. The organizational transparency following this event has been paramount in the development of operational changes, firefighter awareness and development, and the management of "moving on" after a significant event that forever changed our system. This class is taught on a level that ranges from the Chief of Department down to the newest Firefighter where everyone will be able to take away information. This program is geared towards telling firefighters what they need to hear, and not necessarily what they want to hear. The time spent in this class will open student's eyes to how quickly things can deteriorate on a seemingly routine incident and how we need to be prepared for self-survival.

Micah Kiger is a Career Deputy Chief with Loudoun County Fire and Rescue - Virginia. Loudoun is located 35 miles from our nation's capital and is situated between Fairfax, Prince William, and Fauquier County(s) in Northern Virginia and is bordered by the Potomac River to the North, which separates them from Frederick and Montgomery County(s) in Maryland. Micah began his fire service career in Loudoun County in 2000 after successfully completing Recruit Class #4. Since then, he has progressively moved up through the ranks and has served in the positions of Firefighter/Paramedic, Lieutenant, Captain/Station Commander, and EMS Supervisor. Chief Kiger has held assignments as an operational Battalion Chief, Special Operations Battalion Chief, Deputy Chief/Shift Commander, Deputy Chief of EMS, and is currently assigned as the Deputy Chief/Chief Fire Marshal for Loudoun County Fire and Rescue. Chief Kiger has an associate degree in Fire Science from the Blue Ridge Community and Technical College and has a bachelor's degree in Fire Administration through Columbia Southern University. Micah is a certified Paramedic and has worked in the past as a Critical Care Flight Paramedic for HealthNet Aeromedical Services, Inc. Chief Kiger is a part-time adjunct instructor with West Virginia University's Fire Service Extension and has received numerous unit citations for meritorious actions and Life Saving and was awarded the Silver Medal of Honor for actions related to the Meadowood Court Incident. Micah has been a volunteer member of the Shepherdstown Fire Department, Inc. since 1998 and officially began in the fire service in 1996 in the Mannington Volunteer Fire Department. Chief Kiger resides in Shepherdstown, West Virginia with his son, Gabe.



I understand that efforts will be made by the instructional staff to create a working environment that is as safe as possible, and that the instructional staff will give me careful and prudent instruction in the operation of equipment and how to perform each task. However, I also understand that neither KCTCS nor SFRT – nor their respective boards, officers, agents, or employees – has control over these inherent risks, and that the risks cannot be eliminated completely regardless of the care taken by KCTCS or SFRT. By signing below, I represent that I appreciate the risks. I accept and voluntarily assume all risks that may arise from or in connection with my participation in the training. I understand that I am ultimately responsible for my own safety, and for my actions at all times.
2. <u>Participation</u> .
