- Other certifications based on classes to be delivered

State Fire Rescue Training is seeking to build a pool of qualified applicants for the position of Part-Time Adjunct Instructor. These applicants will be considered to fill current instructor vacancies as well as future instructor vacancies.

If these principles align with your teaching methods, we invite you to submit an application to join our team.

Minimum requirements to become an instructor for SFRT include:

- Kentucky Firefighter (Fire Commission certified)
- Level I Instructor Credential (Fire Commission certified)
- IFSAC Accredited Firefighter I
- IFSAC Accredited Firefighter II
- Other certifications based on classes to be delivered

Adjunct instructors are assigned to a District Office but are able to deliver programs anywhere in the Commonwealth.

Anyone interested in applying to be an instructor with SFRT should contact the District Coordinator serving their county for an application.
