

Dwane Smeathers said the Eligibility and Education Committees voted favorably on the proposed changes. Joe Choate motion to approve. Andrew Scott seconded. Jeremy Rodgers said our proposal is concerning the 150-hour, 400 hour and junior firefighter requirements. Jeremy said we want to go to a Kentucky Basic I and II. We also proposed reducing the number of hours from 150 to 115 and from 400 hours down to 300 hours. Jeremy said the administrative regulation now gives us the ability to hold an equivalency. We have the accredited certification program (IFSAC). Jeremy said IFSAC FF I, Awareness and Operations will be the equivalent of Kentucky Basic I. IFSAC FF I, II, Awareness, Operations and Driver Operator Pumper will be the equivalent of Kentucky Basic II. Jeremy said that Ericka Cole and Ashley McWaters created a Junior Firefighter handbook. Jeremy Rodgers said they made the junior firefighter hours match the Kentucky Basic I. Motion approved.

Education Committee

Lonnie Madden said the Education Committee met this morning with Casey Hall concerning the Fire Science Degree Program curriculum.

State Fire Rescue Training

Marc Rudder said that Senate Bill 101 will align high school dual credit programs with college credit hours. Currently there are seven fire related programs in high schools in the State of Kentucky. Marc said there are employment opportunities for these students.

Marc Rudder said through January 31, 2022 SFRT has taught 414 fire departments this year. Marc said that SFRT has taken delivery of a new Hazmat Technician Training prop. It features a rollover tank for a commercial vehicle hauling chemicals or liquids. It has tank simulators. Marc said we hope to train more of our staff on this once the weather warms up. Marc introduced Wes Gilliam to the Commission. Wes started on February 16, 2022 as the District 9 Coordinator in Morehead. Marc Rudder said we do have interviews scheduled for the NRPC Coordinator.

Fire Marshal's Office

Chris Crawford said the Fire Marshal's Office hopes for the revamp of the Kentucky Standards of Safety will be approved within two weeks, which will include the 2018 Edition of 101. Once those are approved, Fire Marshal Haney plans to offer some classes and training on 101 to the updates. Chris Crawford said that the Fire Marshal's Office has hired three new deputies: Ed Lemley, Terry Vanderkamp and Shawn White.

Kentucky Office of Homeland Security

Josh Keats said the Kentucky Office of Homeland Security has been busy. They have had some Cyber intrusions. They are also monitoring numerous other protest activities. Josh said they are working with the FBI to identify a new potential position with the Fusion Center.

Kentucky Firefighter's Association

Eric Philpot said the next meeting of the KFA will be held on Saturday, February 26th at 9:00 am (CST) at the Green River Officer's School. Eric said they have been working on the Memorial expansion with the KPF and with the Fire Commission. Keith Monuments will be coming in tomorrow and presenting some ideas and quotes for the Memorial. Eric said the KFA, Fire Commission and State Fire School committee have been working on hard on getting everything ready for fire school in June.

Kentucky Association of Fire Chiefs

Cathy Rigney said the Kentucky Association of Fire Chiefs will be meeting after the Fire Commission meeting in this room and everyone is invited. Cathy thanked Jeremy Rodgers and the taskforce for all their hard work on the new training hour requirements. Cathy said Brian Steele is in our thoughts and prayers. Marc Rudder said Brian has been extubated and talked to his wife on the phone.

Kentucky Professional Firefighters Association

Joe Baer said the KPFF's primary focus right now is Frankfort. There are a ton of bills that are moving, and some are beginning to move. Joe Baer asked the

Commission to look at the rosters and make sure that the firefighters taken off the rosters are not immediately added back on after the department receives their state aid. Dwane Smeathers said these departments will have a review in six months. They will have to be compliant.

New Business

Bruce Roberts said we are over halfway through the session. There are over 700 bills that have been introduced. Bruce said the Fire Commission, KPFF, KFA and the Fire Chiefs Association have been there every day watching over the bills to see which ones affect the fire service. Bruce discussed the following bills: SB 27, SB 64, SB 101, SB 177, SB 189, HB 1, HB 56, HB 69, HB 135, HB 151, HB 163, HB 164, Hb 169, HB 227, HB 348, HB 356, HB 372, HB 396, and HB 446. Bruce said the big bill on the table right now is HB 505. Joe Baer said HB 505 will split KBEMS. Joe said they met with Representative Mark Hart yesterday on this. Bruce Roberts said when we put something out, please contact your legislators. Bruce said he has copies of all the bills if anyone would like a copy.
